Each unique entry will count as one (1) unique submission. For the avoidance of doubt, each entrant is limited to winning only one (1) prize. There will be a total of three (3) unique winners.

Entry Content Guidelines: Contest materials submitted (text, photos or videos) must comply with the following guidelines:
